RE: Right-to-Know Law Request

Dear Open Records Officer:

Pursuant to the Right-to-Know Law (RTKL), as codified at 65 P.S. §§ 67.101 et seq., Citizens for Responsibility and Ethics in Washington (CREW) makes the following request for records.

- 2. All records November 1, 2020 to the date this request is processed sent by or to Christian Leinbach or Michael Rivera mentioning any of the terms listed above in Part 1 of this request.

Please search for responsive records regardless of format, medium, or physical characteristics. We seek records of any kind, including paper records, electronic records, audiotapes, videotapes, photographs, data, and graphical material. Our request includes without limitation all correspondence, letters, emails, text messages, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions. Our request also includes any attachments to

emails and other records, as well as those who were cc'ed or bcc'ed on any emails. Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks "communications," please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.

Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Right-to-Know Law.¹

If it is your position any portion of the requested records is exempt from disclosure, please cite each specific exemption you feel justifies the refusal to release the information and notify CREW of the appeal procedures available under the law. CREW requests that you state in writing and with particularity the reasons for any conclusion that a record is exempt or confidential. In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records under 65 P.S. § 67.706.

Fee Waiver Request

In accordance with 65 P.S. § 67.1307(f)(2), CREW requests a waiver of fees associated with processing this request for records because disclosure of the requested information is "in the public interest." The public has a significant interest in the administration and certification of elections in Pennsylvania, including the activities of those tasked with overseeing elections who may be involved in efforts to undermine public confidence in elections in Pennsylvania.² The requested records would contribute to public understanding of operations of the government, including whether Pennsylvania public officials have communicated with external entities and individuals engaged in efforts to cast doubt on election results. Furthermore, the request is primarily and fundamentally for non-commercial purposes.

CREW is a non-profit corporation, organized under section 501(c)(3) of the Internal Revenue Code. CREW is committed to protecting the public's right to be aware of the

activities of government officials, to ensuring the integrity of those officials, and to highlighting and working to reduce the influence of money on politics, and the public's understanding of the government's activities would be enhanced through CREW's analysis and publication of these records. CREW uses a combination of research, litigation, and advocacy to advance its mission. CREW intends to analyze the information responsive to this request and to share its analysis with the public through reports, press releases, or other means. In addition, CREW will disseminate any documents it acquires from this request to the public through its website, <u>www.citizensforethics.org</u>. The release of information obtained through this request is not in CREW's financial interest.

CREW routinely disseminates information obtained through records requests to the public in several ways. For example, CREW's website receives hundreds of thousands of page views every month. The website includes blogposts that report on and analyze newsworthy developments regarding government ethics, corruption, and money in politics, as well as numerous reports CREW has published to educate the public about these issues. These reports frequently rely on government records obtained through records requests. CREW also posts the documents it obtains through records requests on its website.

Under these circumstances, CREW satisfies fully the criteria for a fee waiver.

Conclusion

CREW requests that Berks County produce the records within five business days, as required by 65 P.S. § 67.901 and 65 P.S. § 67.902.
