Re: Second Notice of Potential Failure to Preserve, Removal or Destruction of Federal Records by DOGE

Dear Mr. Rubio, Mr. Byron, Ms. Bergman and USDS Administrator:

By letter dated February 14, 2025, we alerted you of the potential failure to preserve, or removal or destruction of, records by the so-called "U.S. DOGE Service" ("DOGE," "USDS"), its staff, its components and Elon Musk. *See* Attach. B. Because it did not appear that DOGE, its staff, its components or Mr. Musk were preserving potential federal records created on X, our letter requested that you immediately investigate and take appropriate remedial action,

pursuant to your mandatory duties under the Federal Records Act.¹ To date, you have not responded to our letter.

Since our February 14 letter, DOGE has expanded its conduct of public business on X, with no indication it is preserving potential federal records. On February 16, DOGE announced on X the creation of DOGE affiliate X accounts for specific federal agencies.<sup>2</sup> These accounts may be related to President Trump's executive order that "each Agency Head shall establish within their respective Agencies a DOGE Team of at least four employees . . . . . Agency Heads shall ensure that DOGE Team Leads coordinate their work with USDS and advise their respective Agency Heads on implementing the President's DOGE Agenda."<sup>3</sup> DOGE itself has posted on X calling on the public to direct message these agency-specific DOGE accounts for ideas on reducing waste, fraud and abuse in the government.<sup>4</sup> Under the "Affiliates" tab of its X profile, DOGE posted links to the DOGE affiliate X accounts for specific federal agencies.<sup>5</sup> Each of those DOGE affiliate X accounts also has a grey verification checkmark, signifying that X has verified it as a "government/multilateral organization."<sup>6</sup> As you are no doubt aware, X is owned and operated by Elon Musk, 7 who President Trump has repeatedly stated has been tasked to lead DOGE.<sup>8</sup>

To date, CREW has identified 31 DOGE affiliate X accounts incidating they are associated with the following agencies: the General Services Administration (@DOGE\_GSA), the Department of State (@DOGE\_STATE), the Small Business Administration (@DOGE\_SBA), the Department of the Interior (@DOGE\_DOI), the Department of Housing and Urban Development (@DOGE\_HUD), the National Park Service (@DOGE\_NPS), the Social Security Administration (@DOGE\_SSA), the Office of Management and Budget (@DOGE\_OMB), the Department of Education (@DOGE\_ED), the Office of Personnel Management (@DOGE\_OPM), the Department of Justice (@DOGE\_DOJ, the National

Aeronautics and Space Administration (@DOGE\_NASA), the Department of Veterans Affairs (@DOGE\_VA), the Department of Agriculture (@DOGE\_USDA), the Federal Aviation Administration (@DOGE\_FAA), the Department of Transportation (@DOGE\_DOT), the Environmental Protection Agency (@DOGE\_EPA), the Department of Defense (@DOGE\_DOD), the Food and Drug Administration (@DOGE\_FDA), the Department of Health and Human Services (@DOGE\_HHS), the Department of Homeland Security (@DOGE\_DHS), the Federal Emergency Management Agency (@DOGE\_FEMA), the Securities and Exchange Commission (@DOGE\_SEC), the Federal Communications Commission (@DOGE\_FCC), the Federal Trade Commission (@DOGE\_FTC), the Department of Energy (@DOGE\_DOE), the Department of Labor (@DOGE\_DOL), the Department of Commerce (@DOGE\_DOC), the Department of Treasury (@DOGE\_TREAS), the Internal Revenue Service (@DOGE\_IRS), and the National Science Foundation (@DOGE\_NSF).9

These DOGE affiliate accounts conduct public business on X. For example, DOGE affiliate X accounts solicit direct messages from the public on X related to finding "waste, fraud and abuse." The Department of Education DOGE affiliate account reposted a post from the main DOGE X account about federal education spending. The General Services Administration DOGE affiliate account responds to suggestions from the public and has on at least one occasion broadcast future agency action. It is unclear just how many private communications these accounts have received or how many federal records these accounts have created.

As we stated in our February 14 letter, posts and direct messages in connection with the transaction of public business on X may be federal records that must be preserved. Despite the obligation of Mr. Musk, DOGE and its staff, and now DOGE affiliates within other agencies to preserve their posts and direct messages, there is no indication they have done so. Given their conduct of government business on X, we reiterate our request that you immediately investigate any failure by DOGE, its staff, DOGE's agency affiliates, their staff or Mr. Musk to preserve such federal records. We further reiterate our request that NARA promptly advise any DOGE or DOGE affiliate staff and Mr. Musk that if they have conducted

Re: Notice of Potential Failure to Preserve, Removal or Destruction of Federal Records by DOGE

Dear Mr. Bosanko and USDS Administrator:

We write to alert you of the potential failure to preserve, removal or destruction of federal records by the so-called "U.S. DOGE Service" ("DOGE"), its staff and Elon Musk. As detailed below, we request the National Archives and Records Administration ("NARA") immediately investigate and take appropriate remedial action in response to any failure by DOGE or its staff, including Mr. Musk, to preserve federal records. We further request that NARA promptly advise Mr. Musk and any DOGE staff that if they have conducted public business on internal communications systems at Mr. Musk's businesses, such communications are federal records that must be preserved. Absent such steps by NARA, we will bring legal action to ensure the government complies with its obligations under the Federal Records Act ("FRA") and other applicable statutes.

Potential federal records created by DOGE, its staff and Mr. Musk include posts and direct messages on Mr. Musk's social media platform, X, including from Mr. Musk's preexisting (@elonmusk) and DOGE's official (@DOGE) X accounts. Communications made through these accounts, as well as accounts on any other social media platform or messaging service, in connection with the transaction of public business may be federal

records that must be preserved pursuant to NARA's mandatory duties under the FRA and other applicable statutes.  $^1$ 

On January 20, 2025, President Trump issued an executive order establishing DOGE to "implement the President's DOGE Agenda, by modernizing Federal technology and software to maximize governmental efficiency and productivity." Earlier, President Trump had announced on his social media platform, Truth Social, that Elon Musk would lead DOGE. With Mr. Musk at the helm, DOGE has reportedly sourced staff from Mr. Musk's existing businesses. Mr. Musk appears to be using his own social media platform, X, to conduct DOGE's public business and had recently updated the description of his X account as "White House Tech Support."

Mr. Musk has used his preexisting X account to communicate about, and purportedly to make, decisions concerning DOGE's actions and priorities. He has posted on X to announce DOGE's actions to shut down entire agencies. Mr. Musk has also posted about potential targets of future DOGE action, including at the Treasury Department and the Food and Drug Administration, and on February 4, 2025, posted a poll asking X users, "Would you

like @DOGE to audit the IRS?"<sup>10</sup> Mr. Musk has also used his preexisting account to communicate the results of discussions with federal agency officials.<sup>11</sup>

Mr. Musk has also used his preexisting X account to communicate about government business, including potential law enforcement actions, with the Interim United States Attorney for the District of Columbia. On February 3, 2025, Interim United States Attorney Edward Martin, Jr., sent a public letter to Mr. Musk via X concerning DOGE. Mr. Musk acknowledged his receipt of the letter on X, replying, "Thank you, receipt via  $\mathbb X$  acknowledged." On February 7, 2025, Mr. Martin posted an additional letter to Mr. Musk concerning DOGE. The post also noted the letter was "[s]ent only via X."  $\mathbb X$ 

Mr. Musk has further used his preexisting X account to communicate about, and purportedly to make, federal government staffing decisions. On February 7, 2025, after a staffer resigned from the Treasury Department following allegations of derogatory social media posts, Vice President Vance responded to a post by Mr. Musk on X about rehiring the staffer. Vice President Vance advocated for the staffer to be brought back, and Mr. Musk responded to the Vice President on X announcing he would rehire the staffer. Mr. Musk has also repeatedly used his X account since January 20, 2025, to post about other issues concerning DOGE staff.

DOGE itself uses its X account to publish information about its policies, functions, and decisions.<sup>20</sup> On November 14, 2024, DOGE posted on X seeking applicants to work at

DOGE and requesting applicants to direct message their CVs to the DOGE account via X.<sup>21</sup> The DOGE X account also has a grey verification checkmark indicating that Mr. Musk's company, X, has verified it as a "government/multilateral organization" since November 2024.<sup>22</sup> Some government officials, including Office of Management and Budget director Russ Vought and Secretary of Defense Peter Hegseth, also have grey verification checkmarks on their preexisting X accounts.<sup>23</sup> At the time of writing, DOGE's official government homepage prominently features a feed of the DOGE's X account's latest posts under a "Latest work" heading.<sup>24</sup> Other than submitting an application through the DOGE website's "Join" page, it appears the only way to contact the agency is through the DOGE account and Mr. Musk's preexisting account on Mr. Musk's platform.

The DOGE X account has open direct messages, meaning that the account administrator can receive direct messages from anyone with an X account. Since the account was created prior to the beginning of the Trump administration, it is unclear whether the administrator of the account is a current government employee or what mechanisms the account administrator is taking to preserve government records created or received by the account.

Mr. Musk's preexisting X account and the DOGE official account also interact to communicate about and conduct DOGE business. Mr. Musk often shares posts from the official DOGE X account, adding his own interpretations and clarifications. <sup>25</sup> The DOGE X account also shares posts from Mr. Musk's X account. <sup>26</sup> And Mr. Musk responds to X users

responding to posts from the official DOGE X account to add further information and context on DOGE's actions.<sup>27</sup>

Congress enacted the FRA to ensure "[a]ccurate and complete documentation of the policies and transactions of the Federal Government." 44 U.S.C. § 2902(1). Toward that end, the FRA imposes on DOGE the obligation to "make and preserve records containing adequate and proper documentation of the organization, functions, policies, decisions, procedures, and essential transactions" of each agency. 44 U.S.C. § 3101. Further, the FRA "strictly limits the circumstances under which records can be removed from federal custody or destroyed."<sup>28</sup>

The FRA further imposes on DOGE's administrator the obligation to "notify the Archivist of any actual, impending, or threatened unlawful removal, defacing, alteration, corruption, deletion, erasure, or other destruction of records in the custody of the agency" and "with the assistance of the Archivist" to "initiate action through the Attorney General for the recovery of [those] records." 44 U.S.C. § 3106(a). Absent such action by the DOGE administrator, the FRA requires NARA itself to "request the Attorney General to initiate such an action, and shall notify the Congress when such a request has been made." *Id.* at § 3106(b).

Posts and direct messages on X by DOGE and its staff, including Mr. Musk, in connection with the transaction of public business may be federal records that must be preserved. NARA guidance provides social media content "that is recorded, made or received in the course of Federal business" is a federal record under § 3301 and is subject to federal record retention laws. NARA further provides that "[e]lectronic messages created or received in the course of agency business are Federal records" and lists "Twitter Direct Message" as a form of electronic message that can be a federal record. NARA guidance additionally notes "[a]gencies must articulate clear processes, policies, and recordkeeping roles and responsibilities to ensure social media records are identified, managed, and captured." Any removal, alteration or deletion of posts and direct messages on X by DOGE, its staff and Mr. Musk is subject to the notice requirements set forth in 44 U.S.C. § 3106.

Additionally, NARA must ensure DOGE, its staff and Mr. Musk preserve any communications made in connection with the transaction of public business using internal

communications systems at Mr. Musk's businesses.<sup>33</sup> For example, discussions related to DOGE's actions on X or efforts to amplify posts by Mr. Musk or the DOGE X account could be considered government business. Any such communications in possession of Mr. Musk's private businesses may be alienated federal records subject to the FRA.

DOGE has publicly acknowledged its records are subject to preservation obligations. DOGE advisor Katie Miller posted on X, "Per the Executive Order @DOGE was reorganized under the Executive Office of the President and subject to Presidential Records." Under the Presidential Records Act ("PRA"), "[t]he United States shall reserve and retain complete ownership, possession, and control of Presidential records." While we dispute that all of DOGE's records are categorically subject to the PRA rather than the FRA, even if they are subject to the PRA, they must be preserved.

Despite the agency's requirement to preserve these posts and messages, there is no indication they have done so. We request that NARA take appropriate action, including instructing DOGE to manage and preserve any federal records and to report any unlawful removal, alteration, or destruction of records to NARA. Please promptly confirm in writing that the agencies have commenced the requested actions.
