PLAINTIFF'S OPPOSITION TO DEFENDANT'S MOTION TO <u>EXCUSE U.S. ATTORNEY'S OFFICE OFFICIAL</u>

A significant portion of this Freedom of Information Act ("FOIA") lawsuit, filed nearly 15 months ago, has been on hold because of the Department of Justice's ("DOJ") invocation of FOIA Exemption 7(A) based on a sealed declaration that purportedly explains how disclosure of the requested records of DOJ's Inspector General ("IG") would cause harm to an ongoing law enforcement proceeding. On three separate occasions—July 9, September 9, and September 30, 2019—DOJ has represented to this Court *in camera* that the need for the protection of Exemption 7(A) continues. At the most recent status conference, the Court expressed its "dismay" that a further continuance was necessary to protect "the interest that both the government and Mr. McCabe have in reference to the dissemination of information about his [McCabe's] situation before a determination of how the underlying matter is going to proceed." Transcript of Status Conference, Sept. 30, 2019, at 7 ("Trans.").¹ The Court made clear it was reluctantly continuing the case until mid-November after considering "what the government will have to

make a call. If it doesn't, I'm going to start ordering the release of information on the next occasion." *Id.* at 11.

The government apparently has now made that call. By notice filed on November 13, 2019 (ECF No. 36), DOJ advised the Court "that it is withdrawing its invocation of Exemption 7(A) over information related to the proceeding described in the Lyons Declaration." Notice of Withdrawal of Exemption 7(A) and Motion to Excuse U.S. Attorney's Office Official, at 1 ("DOJ's Notice"). DOJ offered no further explanation for its withdrawal and also requested that the Court "eliminate any obligation for a U.S. Attorney's Office official to appear at the November 14, 2019, hearing." *Id.* Significantly, in response to questions from plaintiff's counsel about whether in the absence of an appearance by an official from the U.S. Attorney's Office DOJ will be in a position to answer any questions that may arise, including questions about the status of the investigation, DOJ responded that "[q]uestions about the status of the enforcement proceeding are irrelevant to this FOIA case in light of Defendant's withdrawal of its invocation of Exemption 7(A)." D's Notice at 2.

To the contrary, serious questions remain about whether DOJ has been acting in good faith and the extent to which any declaration DOJ may file in the future to defend its withholdings under FOIA Exemption 7 is entitled to a presumption of good faith. As the Court is well aware, since the outset of this litigation plaintiff has questioned the basis for DOJ's withholdings and its concern that with DOJ was relying on FOIA Exemption 7(A) to prevent the disclosure of exculpatory evidence gathered by the IG. This fear recently was confirmed by Mr. McCabe's civil lawsuit,² which identifies that evidence, including an interview the IG conducted

with the FBI's Michael Kortan. *See* Trans. at 8-9; *McCabe v. Barr*, Complaint ¶ 111 (ECF No. 1).

Further, DOJ's motion to dismiss that lawsuit raises additional questions about DOJ's motivation behind its invocation of Exemption 7(A). DOJ justified its departure from the 30-day response time Mr. McCabe should have been afforded to respond to his proposed removal by reference to an FBI SES Policy, which DOJ described as allowing the FBI to curtail that notice to "as little as seven days" "if there is reasonable cause to believe the employee has committed a crime for which a sentence of imprisonment can be imposed[.]" McCabe v. Barr, Memorandum in Support of Motion to Dismiss and for Summary Judgment (ECF No. 23) at 2-3, citing FBI SES Policy at 16. In its motion DOJ argued it had "a sound basis for affording Mr. McCabe seven days to respond" "[g]iven the Inspector General's findings that Mr. McCabe lacked candor under oath . . . there was reasonable cause to believe that Mr. McCabe had committed a crime for which a sentence could be imposed[.]" *Id.* at 3. In other words, not only did DOJ's invocation of FOIA Exemption 7(A) in this case provide the government with a justification for withholding critical documents for months, but it also buttresses DOJ's defense in a civil lawsuit that it properly afforded Mr. McCabe only seven days to respond to his proposed termination—a shortened period that would ensure Mr. McCabe would be terminated before he could collect a government pension he had earned with decades of government service.

In sum, the government's conduct and its months-long insistence that disclosing documents from the long-closed IG investigation would harm an ongoing investigation raise serious questions about the government's conduct and the extent to which it may have abused court processes to advance its own interests over those of the public. In light of these questions, the Court, the plaintiff, and the public are entitled to an explanation for DOJ's sudden and

unexplained reversal. Accordingly, plaintiff respectfully requests that the attendance of an official from the U.S. Attorney's Office at the upcoming status conference on November 14, 2019 not be excused without assurances from DOJ that it will be able to answer any questions that arise at the hearing on November 14 concerning, *inter alia*, the status of the law enforcement investigation at issue here.

4 As you may know, Mr. McCabe has filed his own 5 lawsuit, and that complaint reveals exactly what we had 6 feared, which is, that there is, in fact, evidence that was 7 shared with Mr. McCabe by the IG that is exculpatory. 8 That's referenced in his complaint, but it is not referenced 9 at all in the Inspector General report, so that verifies the 10 concern we had that that report does not fully reflect the 11 outcome of that investigation.

In the mean time there's been a lot of public reporting about the fact that a Grand Jury was released, called back, no indictment is forthcoming. Mr. McCabe and his lawyers have publicly and with the Department of Justice pleaded to know the status. This is like the sword of Damocles over his head.

18 There's also, and I say this, you know, as a 20-plus some year veteran of the Justice Department, but 19 20 sadly we're in dark times where there's growing evidence 21 that the president aided by the attorney general is using 22 the power of his office to go after perceived political enemies. He's going after the intelligence community. He's 23 24 going after the law enforcement community. And we believe 25 that Mr. McCabe was swept up in that.
